## Fee Schedule

$\checkmark$ PANO members fees are based on the annual revenues of applicants' organizations*
$\checkmark$ Non-members pay a flat fee

## Payment Options

$\checkmark$ Option A is for those who wish to pay the full Accreditation fee at the time of submission.
$\checkmark$ Option B offers a payment-plan option. It entails a five percent administrative fee. (This plan provides the opportunity for organizations to spread Accreditation costs over multiple years. It is our hope that this will enable you to maintain your Accreditation as well as allow for easier budgeting for Accreditation.)

Accreditation: Initial Standards for Excellence Accreditation is valid for three years. As this point, organizations must apply for Renewal of Accreditation, which is valid for five years.

Training fees range from $\$ 100-\$ 400$ for members depending on the amount of sponsorships procured.

    **The first payment for the renewal of accreditation will be due six months prior to the expiration. For those choosing the annual payment schedule this will result in two payments within a 12-month period. The initial payment will be applied to the total accreditation fee due.
