87% of nonprofits were negatively impacted by the pandemic - and continued to provide services to those most vulnerable. The state has yet to designate funding to support our work. All of the boards that I serve on have realized the devastating impact that the pandemic has had on our finances. Currently, there is over \$200,000,000 sitting in the Legislative "Slush Fund". This money needs to be disbursed throughout the non-profits and other resources that the COVID rescue money was originally intended for.

Many nonprofits were created to address inequities in policy or programs.* If elected, how would you go about identifying and addressing these inequities?*Examples: Food banks exist to serve those who live in food deserts or have other limited access to food. Suicide hotlines exist to serve those who have no where else to turn when life no longer seems worth living.
